**PET PUPPY CONTRACT/GUARANTEE**

This agreement is entered into this \_\_\_\_\_ day of \_\_\_\_\_, 2010 between  
\_\_\_\_\_ and JAAMA Kennels, Reg.

- 1) This Whippet puppy is being sold as strictly pet quality for a sum of \$850. All costs associated with the shipping/delivery of this puppy to it's new home, are the responsibility of the purchaser (i.e. airfare, shipping crate, etc.). It is understood that this dog is not being sold for breeding purpose or for personal gain but instead as a companion animal. This dog will be registered on an AKC Limited Registration which renders any offspring from this animal unregistrable. Spay/neuter is required by 12 months of age and AKC papers will be held until proof of spay/neuter is received.
- 2) This puppy is guaranteed against all congenital health defects that are found to be debilitating to this dog, would cause this dog to live a compromised life in pain, or would cause this dog to be dependent on medication for the remainder of its life, until the age of two years.
- 3) This puppy is guaranteed against crippling or painful hip dysplasia until two years.
- 4) This puppy has been dewormed and inoculated on a regular schedule and is found to be free of illness upon leaving our premises. Please keep in mind that this puppy's vaccination schedule is not complete and will need to be continued with your veterinarian. It is not recommended to expose your puppy to public places or areas where other dogs are allowed to run until it has completed the entire vaccination regimen. The incubation period for most contagious diseases is 7-10 days. For this reason, this puppy is only guaranteed for 10 days from the date for purchase for contagious diseases. You will be required to take this puppy to your veterinarian within 48-72 hours to have it checked. If this is not done, and the puppy develops a contagious disease and dies within this 10 day period, this guarantee is void and no replacement will be offered.
- 5) It is understood that puppies occasionally will be diagnosed with intestinal parasites or other protozoan/bacterial type disorders (i.e. coccidiosis or giardia) after leaving our premises. All efforts have been made to prevent and/or treat infection of these puppies, but since they are allowed to run and play outside where birds, rabbits, and other wild animals roam, sometimes puppies pick up things that can not be foreseen. For this reason, if this puppy is diagnosed by your veterinarian with an intestinal parasite/condition within 72 hours of purchase, JAAMA Kennels agrees to reimburse the purchaser for the cost of medication to remedy the condition, not to exceed \$25 total.
- 6) This puppy will be registered with the AKC registered kennel prefix JAAMA preceding all other parts of the registered name.
- 7) The purchaser agrees to notify JAAMA Kennels should it ever become necessary to get rid of this dog. JAAMA Kennels retain the right to request the dog be returned to them for placement.
- 8) Should a replacement be warranted for health reasons as outlined in the above clauses, it will be in the form of another puppy. This will be from JAAMA's next litter and be of the same sex and quality as the one originally purchased.
- 9) Should the purchaser change their mind regarding purchasing this puppy, they have 48 hours in which to return this puppy to Jaama Kennels (at the purchasers expense) for a full refund of the purchase price, provided the puppy is healthy and unharmed and all paperwork is returned. If the puppy is returned after this 48 hour period but within 14 days from purchase, a 50% refund will be made with like requirements for health and paperwork. If the 14 day period is exceeded no refunds will be guaranteed and Jaama requests the dog be returned to them for placement as per the terms spelled out in clause 7.
